COMES NOW CLIENT, by and through counsel of record, ATTORNEY of FIRM, and moves this Court to order FATHER to show cause, if any he has, why he should not be held in contempt for failing to comply with the Order of the Court made on January 21, 2003. Respondent counsel makes this motion based on the following facts:

1. On January 21, 2003, a Protective Order was issued against FATHER which prohibited Mr. FATHER from directly or indirectly contacting CLIENT (See Exhibit 1: Protective Order).

2. On March 20, 2003 CLIENT called FATHER to discuss his visitation with

AnnMarie. Mr. FATHER's stated that he had taken a bunch of pills in an attempt to commit suicide. Ms. FATHER called the West Valley Police Department (See Exhibit 2: Affidavit of CLIENT).

3. After being visited by the Police, FATHER continued to call repeatedly and harass CLIENT. Ms. CLIENT called the West Valley Police Department to report that Mr. FATHER had violated the Protective Order.

4. The following day, on March 21, 2003, FATHER continued to call and harass CLIENT. Ms. CLIENT again called the police to report that Mr. FATHER had violated of the Protective Order.

5. Upon information and belief, the West Valley Police Department arrested FATHER for violation of the Protective Order.

WHEREFORE, it is respectfully requested the Court find that the Petitioner willfully and intentionally failed to comply with the Order of the Court and the following Order should be entered:

1. That FATHER is in contempt of court.
2. That pursuant to both the Protective Order and the Order of this Court, FATHER is prohibited from directly or indirectly contacting, harassing, telephoning or otherwise communicating with Ms. CLIENT with the exception of arranging visitation.
3. That upon violation of these orders, FATHER be remanded into custody and ordered to serve jail time, at the discretion of this Court.
4. That FATHER bear the legal costs of Respondent Counsel for bringing this Order to

Show Cause in that Mr. FATHER has violated a Court order and has not been willing to resolve this matter without court intervention.

(4) Any other equitable relief as deemed appropriate by the Court.
