MEMORANDUM

FACTS:

1. This Court has entered an Order of Custody, Support, Visitation and in April 1998 and October 3, 2000.

2. Since that time Respondent has been prevented from visiting the parties minor child.
3. On September 19, 2000, the State of Utah, Division of Child and Family Services filed a Verified Petition regarding the parties minor child CHILD, born November 00, 0000, Case No. 000000000 before the Honorable JUDGE. (See, Minutes, attached as Exhibit 1).

ARGUMENT:

Rule 4-902(1) of the Utah Rules of Judicial Administration provides: In district court cases where there is a question concerning the support, custody or visitation of a child and a petition concerning abuse, dependency, or neglect of the same child has been filed in juvenile court, the district court shall certify the question of support, custody or visitation to the juvenile court for determination.

There is a Verified Petition in the Third Judicial Juvenile Court pending adjudication, thereby, raising the question of visitation and support. As such, pursuant to rule 4-902(1) of the Utah Rules of Judicial Administration mandates that pending matters of support, custody or visitation be certified to the Third District Juvenile Court for determination.

WHEREFORE, Respondent respectfully moves this Court for an order of certification to the Third District Juvenile Court, Case No. 000000.
